FEE ALLOCATION REQUEST FOR I-80/SR 65 INTERCHANGE -

PHASE 1

ACTION REQUESTED

Adopt Resolution #17-05 to allocate \$1,200,000 of Regional Transportation and Air Quality Mitigation Fees to the Placer County Transportation Planning Agency (PCTPA) for the I-80/SR 65 Interchange – Phase 1.

BACKGROUND

The Regional Transportation and Air Quality Mitigation Fee Program ("Fee Program") includes \$5 million for the reconstruction of the I-80/SR 65 Interchange. The Board has previously allocated \$3 million for Phase 1 improvements to match funding from Caltrans' State Highway Operations Protection Program (SHOPP), the Trade Corridors Improvement Fund (TCIF), Highway 65 JPA funds, and the Federal earmark fund savings from the I-80 Bottleneck project.

The I-80/SR 65 Interchange - Phase 1 improvements will add a lane between the westbound I-80 to northbound SR 65 connector ramp and the Galleria Blvd/Stanford Ranch Rd off ramp, extend a third general purpose lane northbound to the Pleasant Grove Blvd off ramp, widen the Galleria Blvd/Stanford Ranch Rd northbound off ramp and southbound on ramp, add turn lanes onto SR 65 from Galleria Blvd/Stanford Ranch Rd, and make additional operational improvements.

DISCUSSION

While the improvements to the I-80/SR 65 Interchange are a top priority for Placer County, this allocation request will do even more.

This \$1.2 million allocation request will allow us to attract Caltrans operational improvement funds to build two auxiliary lanes to relieve congestion on I-80; one will extend a lane westbound through the Douglas Blvd Interchange all the way to Sacramento County, while the other is eastbound, extending a lane that currently drops off between SR 65 and Rocklin Road to become a dedicated off ramp lane.

Put simply, if we pay for the design of the project, Caltrans will work to find the money for construction.

Unfortunately, the I-80 Auxiliary Lanes project described above is not included in the Fee Program so we cannot allocate the funds directly. However, if we augment the allocation to the I-80/SR 65 Interchange, we can free up an equal amount of Federal earmark savings that are eligible for use on the I-80 Auxiliary Lanes.

PCTPA has already completed the environmental clearance on this project, and with this allocation can move forward with a design contract immediately. With quick action, it is our expectation that this project could be under construction in 2019.

The SPRTA Technical Advisory Committee (TAC) concurs with the proposed allocation.

WHEREAS, the Placer County Transportation Planning Agency (PCTPA) is providing funding for the I-80/SR 65 Interchange Improvements Project; and

WHEREAS, it has been determined there is a significant savings through matching dollars from Caltrans for the I-80/SR 65 Interchange Phase 1A for design, right-of-way, and construction;

NOW, THEREFORE, BE IT RESOLVED THAT the Authority allocates an additional \$1,200,000, for a total of \$4,200,000, to the PCTPA for expenditure for the I-80/SR 65 Interchange Phase 1A.

SUBJECT: REGIONAL TRANSPORTATION AND AIR QUALITY MITIGATION

FEE ALLOCATION REQUEST FOR SR 65 WIDENING

ACTION REQUESTED

Adopt Resolution #17-06 to allocate \$1,000,000 of Regional Transportation and Air Quality Mitigation Fees to the Placer County Transportation Planning Agency (PCTPA) for the design of the SR 65 Widening Project.

BACKGROUND

The Regional Transportation and Air Quality Mitigation Fee Program ("Fee Program") includes \$67 million for the widening of SR 65 from the terminus of the I-80/SR 65 Interchange improvements to Lincoln Blvd. The project will add mixed flow lanes and auxiliary lanes in both directions, for a total of 8 lanes, up to Blue Oaks Blvd, then adding auxiliary lanes where they do not exist between Blue Oaks Blvd and Lincoln Blvd, for a total of 6 lanes. Phase 1 of the project would complete the improvements up to Blue Oaks Blvd.

PCTPA will soon be completing the environmental document for the SR 65 Widening, with final approvals expected in December 2017.

DISCUSSION

One of the keys of our success in moving projects is to have them "shelf ready", so that we can best compete if and when new funding sources come available.

It is true that the main funding source identified for the SR 65 Widening is the Fee Program, and it will be many years before enough funds are saved up to begin construction. In the meantime, completing the design of the Phase 1 project would make the project much more attractive for leveraging the Fee Program and bringing in competitive funding sources to get the project constructed sooner.

The SPRTA Technical Advisory Committee (TAC) concurs with the proposed allocation.

Technical Advisory Committee Meeting Minutes

August 8, 2017 – 2:30 p.m.

I. <u>Generating a Shelf: Discussion of ideas for using SPRTA funds for leverage in preconstruction of:</u>

I-80 Auxiliary Lanes / SR 65 Widening: Celia McAdam explained that she wants to keep the momentum going toward shelf-ready projects. McAdam passed out an allocation and cash flow spreadsheet showing the cash flow supports additional allocations. McAdam noted that the paybacks for Sierra College and Auburn Folsom are reflected in this spreadsheet. In order to position the I-80 Auxiliary Lanes project for construction, McAdam proposed to use \$1.2 million for the I-80/SR 65 Interchange to free up earmark money for the I-80 Auxiliary project design. Once design was complete, Caltrans has committed to finding construction funds.

Celia McAdam provided another spreadsheet and explained the three options for constructing Phase 1 of SR 65 Widening. McAdam explained that there is an opportunity for counties who have a regional fee program, such as SPRTA, to get a piece of the local partnership money which is \$200 million a year for the first three years. McAdam noted that Option 3 assumes no substructure on shoulders which would mean a design exception which may be difficult to obtain. The first step is to allocate \$1 million to design Phase 1.

Celia McAdam added the other project for allocation consideration is Phase 2 of the Third Track project, which would get us ten round trips per day on Capitol Corridor. With the money slated for congested corridors under SB 1, a \$1 million commitment from the fee program could position ourselves for a match under the local partnership program.

The TAC concurred with these strategies as outlined to keep us moving toward construction / shelf-ready projects.
