SUBJECT: METROPOLITAN TRANSPORTATION PLAN/SUSTAINABLE

COMMUNITIES STRATEGY AND REGIONAL TRANSPORTATION

PLAN WORKSHOP

ACTION REQUESTED

Staff recommends that the Board conduct a workshop with elected officials throughout Placer County on the update of the Placer County Transportation Planning Agency (PCTPA) Regional Transportation Plan and the Sacramento Area Council of Governments (SACOG) Metropolitan Transportation Plan/Sustainable Communities Strategy, including:

- 1) Receiving a presentation by PCTPA and SACOG staff; and
- 2) Providing feedback to staff on the process, assumptions, and remaining tasks to complete the update of the plans for both agencies.

BACKGROUND

As the state-designated Regional Transportation Planning Agency (RTPA) for Placer County, PCTPA is required to prepare and adopt a Regional Transportation Plan (RTP) every five years. The last RTP was adopted in 2016. The RTP is a long range (20-year minimum) transportation funding plan that identifies the County's priorities in addressing traffic congestion, mobility needs, and maintenance of the existing transportation infrastructure. Staff kicked off the RTP update in November 2017 and has presented two status updates to the Board. The RTP is scheduled for adoption in December 2019. Preparation of its own RTP provides Placer County with an ability to retain local control of transportation projects, funding and priorities.

SACOG is the state designated RTPA for Sacramento, Sutter, Yolo, and Yuba counties and is also the federally designated Metropolitan Planning Organization (MPO) for the six-county region including Placer and El Dorado. SACOG is also in the midst of an update to the six-county Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS). The MTP/SCS update goes above and beyond PCTPA's RTP. SACOG's MTP/SCS is scheduled for adoption in February 2020.

DISCUSSION

The Board requested that PCTPA and SACOG staff conduct a countywide workshop on the coordination efforts among the two agencies to update the individual plans. The goal of the workshop is to provide a greater understanding of the:

- Advantages of preparing the update of the RTP and MTP/SCS at the same time,
- Regulatory requirements including State Green House Gas Reduction mandates,
- Significance and future use of each plan,

- Underlying land use and transportation projects and assumptions, and
- The processes leading to adoption of the plans.

Staff will specifically discuss the development of the SACOG Discussion Draft Sustainable Communities Strategy and the progression toward a Draft Preferred Scenario. Additional informational materials will be available at the workshop.

The Lincoln City Council and Lincoln Planning Commission conducted a similar workshop on October 24th with SACOG and PCTPA staff.

Staff can conduct additional workshops as the PCTPA and SACOG Plans proceed in 2019.
