EXECUTIVE DIRECTOR'S REPORT

Mike Luken reported on the following:

- 1) PCTPA employees are now allowed to work up to five days a week in the office given the red tier that Placer County is now under.
- The intent is to have the April Board Meeting in-person, at the Board of Supervisors Chambers. Board Members, staff, and consultants will be allowed to attend remotely.
- 3) The April Board Meeting will include:
 - a) A public hearing on Health Express and new Placer Rides Program
 - b) Amendment #2 for FY 2020/21 Overall Work Program and Budget
 - c) It's expected that we will have a SPRTA Board Meeting
- 4) The Northern California Mega Region will meet on Friday, March 26. We will report the results at the April Board Meeting
- As part of the settlement for the Sierra Club for the SR 65 project, we performed a preliminary feasibility study to look into rail to Lincoln. The draft results will be given at a public hearing in the spring.
- We are working with the TAC to look at additional funding for HIP funds and stimulus funding.
- 7) We currently have our recruitment open for the Deputy Executive Director position. This position closes April 9.

- 8) Sutter County has applied for funding for PA&ED for Baseline Riego Road through SACOG's regional local grant program. Award recipients are expected to be announced next week.
- 9) A video from a KCRA Channel 3 interview was shown.
- 10) A video for "Keep Placer Moving" and upcoming Online Community Meetings was shown. This video is being distributed widely in Placer County.
